#### Explanation of Responses:

- 1. On August 23, 2004, the reporting person instructed the administrator of the Thrift and Investment Plan (a trusteed 401(k) Plan) to transfer fund units equivalent in value to approximately 1,472 whole shares of Norfolk Southern Corporation Common Stock into other investment options available to the reporting person and to all other participants in that Plan. Based on the unit accounting system used by the Plan administrator, this shift resulted in an exempt intra-Plan disposition and transfer of the value of the number of shares indicated.
- 2. Represents the approximate number of whole shares of Common Stock estimated -- on the basis of the unit accounting system used by the Plan Administrator -- as of August 23, 2004, the last date on which a formal statement was available, to have been credited to the reporting person's account in the Norfolk Southern Corporation Thrift and Investment Plan (TIP), a trusteed 401(k) plan. In accordance with TIP's terms applicable to all participants, acquisitions were made at various times and at various prices. Includes 61 shares of Common Stock acquired under TIP since June 10, 2004 (the date of the reporting person's last ownership report).
